 - a. The bids for the mowing of the dams were opened at the Technical Committee meeting. The winning bid was awarded to John Anderson *for* \$31,600.00.

He stated that both students were outstanding and received other scholarships as well. D. Verhoff recommended two books. The first book was *Hidden Path of Nature* written by David Montgomery, and the second book was *Shepard's Life* written by James Rebanks.
- S. Sharpe announced that Virginia Extension will be sending out a newsletter featuring many upcoming program opportunities. She shared that Virginia Tech Cooperative Extension has been interviewing candidates for the new Extension Director, no decision has been made at this time.
 - R. Bradford attended a Pasture Walk at Jordan Farm.
- S. Morris attended the Rivanna River Basin Commission Meeting and requested water quality test results; they have not yet been received.
- T. O'Halloran attended the Rappahannock River Basin Commission Meeting and shared that there was a focus on the environmental impact on agricultural soils from solar development. He also shared that Peter Schoderbek, VDOF, came to help him make plans to improve his forestland.
- L. Graves announced that he and S. Yager came in second place at the VASWCD Golf Tournament with a score of 61, first place score was 60. Fourteen teams attended. He shared that the Association Quarterly Meeting will be on June 22nd.

8) STAFF REPORTS

R. Jacobs reported that he and his wife recently welcomed a new healthy baby girl and that mom, baby, and the whole family are doing well. He shared that later this month, PBS will be doing a segment on Virginia Conservation Assistance Program (VCAP) on their Virginia Home Grown show.

- W. Yager attended the Pasture Walk at Jordan Farm and shared that it was well attended. He also went to the Grazing School at Wilbanks and shared that the interest in that event was very high and well attended by producers.
- D. Massie reported that the Grazing Field Day in Culpeper will take place on June 16th at Lakota Farm from 4-7 PM and will include dinner.
- G. Wichelns reported that eight submissions were received for the engineering services term contract qualifications review. The submissions will be reviewed before the August Board Meeting for approval. G. Wichelns also reported that the TMDL Grant for Mountain Run and Muddy Run watershed is still underway and will be submitted before the August Board Meeting. He also shared that due to a newsletter mailing delay caused by the company chosen to print the newsletters, the Strategic Planning Survey will remain open until a later date. G. Wichelns reported that the State has not yet approved a District Budget. He also reported that a High School student from Rappahannock High School will be spending a day or two at the District office as part of the school's Pathways Academy Shadowing Experience to get a feel for what a career in this field might be like.

9) AGENCY REPORTS

<u>DCR</u> – D. Cross submitted a written report and discussed a few items from the report including proposed SWCD funding in the proposed State Fiscal Year 23 budget and the news of a new Ag Incentives Program Manager named Sara Bottenfield who began in the position on May 25th. She also brought attention to upcoming trainings and other important dates. D. Cross congratulated Culpeper District staff on reaching the goal of 90% allocation.

NRCS – R. Rexrode submitted a written report and highlighted some of the items on the report. He updated the Board on the status of the 23 EQIP pre-approvals, twelve of which have now been completed and obligated. R. Rexrode also announced that the Memorandum Agreement between NRCS and SWCD will be updated with the potential of both agencies implementing "back and forth" equipment use. He also reported that the Culpeper Service Center staff member who is expecting a child is planning her maternity leave and that the office is prepared for her absence.
