The Associate Directors and the District Manager were invited to attend. T. O'Halloran seconded the motion. (R. Runkle, T. O'Halloran, unanimous)

Following the return from Closed Session, R. Runkle moved to reconvene at 10:36 A.M. (unanimous). Pursuant to the Code of Virginia Section 2.2-.3712. (D), "I move that the Board certify that to the best of the Board's knowledge only matters lawfully exempted and as identified in the motion by which the Closed Session was convened were heard or discussed by this Board". P. Morris seconded the motion. (R. Runkle, P. Morris, unanimous)

R. Bradford moved to accept the recommendations from the Personnel Committee. S. Hill seconded the motion. (R. Bradford, S. Hill, unanimous)

#### 7) DIRECTOR REPORTS

R. Bradford reported that he attended a Forestry Tour outside of the District where the Hardwood Initiative is of high focus. He reported that white oak is used in the bourbon and wine industries to create barrels and that the specific wood is in high demand and the competency of long term supply of concern.

D. Verhoff reported that the Virginia Association for Biological Farming will be having its 23<sup>rd</sup> Annual Virginia Biological Farming Conference January 6-8, 2023. He passed around documents containing additional information.

B. Jarvis reported that the Pesticide Collection Program had the largest turnout since the first time it was conducted, with about 5 tons of pesticide disposed of. He reported that he will be hosting Pesticide Certification courses on December 5<sup>th</sup> from 6-9 and December 7<sup>th</sup> from 9-12. He also reported that on November 5<sup>th</sup> from 9-12 he will be hosting a Horse Trailer Safety course, and that November 7<sup>th</sup> there will be a gathering with Virginia Motor Carriers and State Police to discuss Farm Use Tags and Weight Limit Exemptions.

S. Sharpe reported that she will be hosting a Farm Transition Workshop, the flyer of which was handed out prior to the meeting. This will be an opportunity to learn about Estate Planning with the help of a lawyer and a CPA who will be in attendance.

R. Runkle reported that at the Farm Bureau Legislation Meeting, farm use tag regulation complaints were addressed and that Farm Bureau will be sending comments to the General Assembly.

L. Graves reported that he attended the Virginia AgriBusiness Council Meeting with Matthew Wells and Andrew Smith where Cliff Williamson was recognized as the new Executive Director. He also reported that on November 13<sup>th</sup> he attended the VASWCD Meeting.

#### 8) STAFF REPORTS

S. Ross reported that the District's Annual Banquet will be on November 17<sup>th</sup> and reminded all to RSVP. She also reminded all that to attend the VASWCD Annual Meeting, you must pre-register, and brought forms for interested parties. She also reported that the District Audit will be on Monday, December 19<sup>th</sup>.

S. DeNicola reported on the NOAA funded MWEE program. In Greene she reached 300 students, Culpeper reached 250 students, and Floyd T. Bins reached 180 students. She reported that all of the events went well and that the children enjoyed being outside. She also reported that the Envirothon training will be held at Graves Mountain Lodge on November 19<sup>th</sup>.

D. Massie reported that the District received two out of the ten Grand River Basin Clean Water Farm Awards available. The Rappahannock River Basin Award recipient is Heaven's Hollow Farm owned by the Gilley's, and the York River Basin Award recipient is Lakeland Farm, owned by the Sedwick's. The awards will be given to the recipients at the Annual Meeting.

G. Wichelns reported that he received notification for the approval of the new 319 Grant for Mountain Run/Muddy Run in Culpeper County and that it is expected to open by November 2023. Also, a new TMDL area is within Greene and Albemarle counties with Blue Run, Quarter Creek, Swift Run, and Stanardsville Run. This area is unique, because unlike others, its main impairment is the benthic community is degraded by sediment and indirectly by phosphorus. The Rivanna Conservation Alliance, UVA, and TJSWCD also have interest in this TMDL area.

#### 9) AGENCY REPORTS

 $\underline{DCR} - D$ . Cross submitted a written report and highlighted a few items on it. She reported that SWCD disbursement letters will be sent on November 9<sup>th</sup> and that deposits should occur within 30 days of receipt. She also reported that Katherine Kulbok has taken the position as Representative for SWCD issues at the Office of the Attorney General and provided her contact information. She reminded District Staff to complete their IT Security Awareness Training and that End of Lifespan Verifications need to be complete, both by November 30<sup>th</sup>.

<u>NRCS</u> – R. Rexrode submitted a written report and read a few items from it. He shared that NRCS State Conservationist, Edwin Martinez, came to the office on November 11<sup>th</sup> for a meet and greet and thanked G. Wichelns for his participation in such. He also reported that C. Bray has been certified as a level one Conservation Planner and that C. Kidwell is back from maternity leave and is now in the office three days per week.

<u>VDOF</u> – K. Ingram touched on the topic of the White Oak Initiative that was previously mentioned in R. Bradford's Director's Report. VDOF has a Cost Share Program for improving hardwood growth that is run by Joe Rosetti. He also reported that there is currently an open Forester position in the Department that is expected to be filled soon and that three additional positions are expected to become available shortly after, including two technician positions and one Forester position. He also reported that 2023 VDOF Calendars are in and that he will bring them to the next meeting for anyone who is interested.

## **10) PUBLIC COMMENT**

L. Graves announced that the Virginia Chapter of the American Soil Conservation Society -Conservationist of the Year Award Recipient was Beauregard Farm and welcomed their Farm Manager, Jamie Shenk, to the District Board Meeting.

D. Massie reminded the Board that they had submitted the nomination of Beauregard Farm for this award back in October, 2021. He shared that the farm practices have been exceptionally well managed and named several accomplishments. D. Massie and L. Graves presented Jamie Shenk, Farm Manager of Beauregard Farm, with the award.
