20) The District Manager gave an update on the dams:

- a. Wave berm construction on Mountain Run #13 (Merrimac) has been completed. The contractor will seed and mulch soon. The District will soon receive funds for the beaver removal, sediment removal from the primary spillway, and debris associated with the clean-up.

- b. Concrete repairs have been completed on Mountain Run #8A (Caynor) and Mountain Run #13 (Merrimac). Beavers are present at this time at both locations, and removal will commence soon.
- c. The wave berm construction, gate valve replacement, and dam embankment regrading on Beautiful Run #1B will begin soon. Iron work on the primary spillway may be included in the scope of work.
- d. The District has applied for funds for the design and construction of a wave berm and gate valve replacement at Beautiful Run #6.

- 21) A request was made to the District for one-time assistance to replant a FR-1 practice (tree planting), which experienced a failure due to drought. This request will be sent to DCR for approval.
- 22) The Technical Committee reviewed the Annual Plan of Work. The Committee felt that all was being addressed. *During the review, there was discussion on the ever-growing administrative burden that Staff is experiencing with the VACS Program. A request was made to communicate some of our concerns to appropriate individuals at Virginia Farm Bureau, Virginia Agribusiness Council, and the Department of Conservation and Recreation. Of particular concern, but not solely, is the inordinate amount of time being spent on the computer and how this is negatively impacting Staff's time with clients in the field. Numerous other Districts have the same concerns.*
- 23) The Technical Committee Chairman requests authority from the Board to approve any new applications, payments, and associated tax credits before the end of the calendar year.
- 24) *On November 15, 2024, the United States Secretary of Agriculture, Thomas J. Vilsack, determined that the drought conditions in Virginia warranted a Secretarial natural disaster designation. This affects cover crop planting dates for the cost share program. The Technical Committee Chairman requests that the Board grant an extension of up to 14 days beyond the standard planting dates for SL-8, SL-8A, SL-8B, SL-8H, SL-8M, NM-7, WFA-CC, and WQ-4 practices. District Staff will make appropriate notes and documentation in each contract file.*

R. Bradford made a motion to grant an extension of up to 14 days beyond the standard planting dates for the practices named in Extreme Acts of Nature letter from the Secretary of Agriculture, Thomas Vilsack. M. Sands seconded the motion. (R. Bradford, M. Sands, unanimous)

R. Bradford made a motion to accept the Technical Committee Report with Additions. M. Sands seconded the motion. (R. Bradford, M. Sands, unanimous)

6) CLOSED SESSION: PERSONNEL MATTERS AND LITIGATION

R. Runkle moved that the Board go into Closed Session at 10:14 A.M. as provided for in the Code of Virginia Section 2.2-3711(A) (1) and (7) to discuss Personnel Matters and Possible Litigation. The Associate Directors and the District Manager were invited to attend. R. Bradford seconded the motion. (R. Runkle, R. Bradford, unanimous)

Following the return from Closed Session, R. Runkle moved to reconvene at 10:25 A.M. (unanimous). Pursuant to the Code of Virginia Section 2.2-3712. (D), "I move that the Board certify that to the best of the Board's knowledge only matters lawfully exempted and as identified in the motion by which the Closed Session was convened were heard or discussed by this Board". D. Cox seconded the motion. (R. Runkle, D. Cox, unanimous)

R. Bradford moved to accept the recommendations from the Operations and Personnel Committees. R. Brame seconded the motion. (R. Bradford, R. Brame, unanimous)

7) DIRECTOR REPORTS

S. Sharpe informed the Board that Greg Lillard has been appointed to the Agriculture Extension Agent position in Madison County. She further noted that she is currently in the process of planning several workshops, though the specific dates have not yet been confirmed. These workshops will cover topics including Beef Nutrition, How to Start a Farm, Farm Economy, Farm Transition Planning, and Starting a Farm as a Business.

R. Brame expressed his sincere appreciation to the District for selecting him as the recipient of the Conservationist of the Year award. He provided a reflective account of his involvement with the District and the improvements made to his land, dating back to before his tenure as a Director.

A. Jewett conveyed that he is personally acquainted with Greg Lillard and expressed confidence in his qualifications and that he is an excellent choice to fill the Agriculture Extension Agent position in Madison County.

R. Williamson reported on his participation in both the Virginia AgriBusiness Council meeting and the Virginia Farm Bureau Legislative meeting, each attended by several key figures from the General Assembly. He highlighted that both organizations voiced their support for the District's position regarding the alleviation of the growing administrative burden placed on staff.

L. Graves reported that approximately 300 individuals attended the Envirothon Training event at Graves Mountain Lodge. He extended commendations to Stephanie for her exemplary organization of the event, noting that he received numerous positive remarks regarding her efforts. He also reported that he will be attending the VASWCD Annual Meeting in Roanoke next week.

8) STAFF REPORTS

S. DeNicola reported that she thoroughly enjoyed hosting the Envirothon, which was a success. She reminded the Board about the ongoing tree sale and provided an update, noting that about a dozen orders have already been received.

R. Jacobs reported that he will be co-hosting a Rain Garden and Native Plants workshop with Ashley Appling from Virginia Cooperative Extension at the Carver Center on December 5, from 10:00 a.m. to noon. He stated that 16 individuals are currently registered to attend. Additionally, he mentioned that he will be participating in a meeting with the Department of Environmental Quality (DEQ) next week to discuss revisions to the Stormwater Handbook.

G. Wichelns extended congratulations to staff for their outstanding efforts in hosting the Awards Banquet in November. He also recognized Kendall and Spencer for their exemplary work in relocating the office in Orange while successfully managing their existing workload. He then provided an update on the 319 grants for the Lower Rapidan (E. coli impairment) and North Fork Rivanna (Benthic impairment and E. coli impairment) areas, noting that the final Implementation Plan (IP) meeting has been completed, and that two draft IPs are currently undergoing the approval process. Additionally, he provided an update on the dams, reporting that one has been completed, and another is approximately 30% completed. He expressed optimism that all projects will be finalized by the end of January.

9) AGENCY REPORTS

DCR – D. Cross submitted a written report and highlighted several key items. She began by congratulating the District for hosting two recipients of the Virginia River Basin Awards: Swift Run Farm and Rocklands Farm. She then reviewed other key points from her report, including a reminder that Quarterly Reports for the second quarter of FY25 are due on January 15, 2025. She also reminded the Directors of their obligation to complete FOIA Training. Additionally, D. Cross noted that, under the Extreme Acts of Nature (EAN) provisions, the Virginia Soil and Water Conservation Board (VSWCB) and the Department of Conservation and Recreation (DCR) have authorized Districts to extend the cover crop planting deadlines. She then informed the group that the Area Meetings scheduled for December 9 will include the election of officers—Chair and Vice-Chair—and that nominations may be submitted, with the clarification that all nominees must be active farmers. Finally, she reviewed several upcoming important dates.

NRCS – R. Rexrode reported that a member of the office staff has resigned to assist his family, leaving the position currently vacant. He also mentioned that three staff members volunteered at the Envirothon Training. Furthermore, he reported that a 700-acre Agricultural Land Easement (ALE) is

nearing closure, and that 54 EQIP projects are currently being ranked and are becoming eligible for funding.

VDOF – K. Ingram reported that the agency has hired a new Forester for Orange County, Griffin Robeson, who will begin his position on January 10th.

10) PLAN FOR DECEMBER COMMITTEE MEETINGS


