20) District staff gave an update on dams:

- a. The second mowing of District dams is underway.
- b. Portions of Beautiful Run #1B will be reseeded this fall. A fence was also installed near the wing wall of the emergency spillway to prevent livestock access to the spillway.

21) Subsequent to the September 2, 2025 District Board Meeting, which was attended by Ms. Stephanie Cornnell, Area II Representative on the Virginia Soil and Water Conservation Board (VSWCB), David Massie reported on his attendance at the VSWCB's Audit Subcommittee Meeting where the District's Cost Share and Technical Assistance Assessment was discussed. David will report to the Board on that meeting and the farm visit the day prior where Engineering Job Approval Authority (EJAA) was discussed. Follow up communication was received from both Ms. Cornnell and the Audit Subcommittee (see attached).

A. Jewett recused himself during the Technical Committee discussion and abstained from the vote.

R. Bradford moved to approve the Technical Committee Report and Additions as presented. S. Morris seconded the motion. (R. Bradford, S. Morris, unanimous)

6) CLOSED SESSION: PERSONNEL MATTERS

R. Runkle moved that the Board go into Closed Session at 10:11 A.M. as provided for in the Code of Virginia Section 2.2-3711(A) (1) to discuss Personnel Matters. The Associate Directors and the District Manager were invited to attend. M. Sands seconded the motion. (R. Runkle, M. Sands, unanimous)

Following the return from Closed Session, R. Runkle moved to reconvene at 10:40 A.M. (unanimous). Pursuant to the Code of Virginia Section 2.2-3712. (D), "I move that the Board certify that to the best of the Board's knowledge only matters lawfully exempted and as identified in the motion by which the Closed Session was convened were heard or discussed by this Board". A. Jewett seconded the motion. (R. Runkle, A. Jewett, unanimous)

R. Brame requested Board authority for the Personnel Committee to act on behalf of the Board until the November Board Meeting. R. Bradford moved to accept the recommendations from the Personnel Committee. R. Williamson seconded the motion. (R. Bradford, R. Williamson, unanimous)

7) DIRECTOR REPORTS

R. Williamson reported that Carl Stafford, Culpeper County Ag Extension Agent, will retire at the end of December and that there will be a celebration at the Carver Center on December 12 to recognize his years of service.

S. Sharpe reported that she will be hosting an open house at the new Greene County Extension office on October 9. She will also host an educational session on well water and septic systems,

featuring special guest Phillip Brown from Virginia Tech, on November 4 at the Greene Extension Office.

A. Jewett reported receiving positive feedback on the District's conservation efforts while attending the Taste of the Mountains event in Madison County.

L. Graves reported that he was unable to attend last week's VASWCD (Virginia Association of Soil and Water Conservation Districts) meeting. However, he did attend the Rappahannock River Basin Commission meeting, where members toured a local data center and learned about the tax revenue it generates, as well as challenges related to cooling methods and potential remedies. He also noted that PFAS (PFOS/PFOA) is being regulated in Virginia through HB 1085 (House) and SB 243 (Senate), which established an Expert Advisory Committee and monitoring/reporting requirements. Virginia waterworks are expected to spend \$643–900M in capital costs to install PFAS treatment infrastructure, with ongoing annual operations and monitoring costs in the tens of millions of dollars per year (approximately \$100M). Separately, Virginia addresses plastics and microplastics through other programs and funding, which are not included in the PFAS cost estimates.

8) STAFF REPORTS

S. Ross reminded the Board of the FOIA and COIA training requirements and of the upcoming deadlines to register for the VASWCD Annual Meeting.

S. DeNicola reported that she will be conducting school educational programs through mid- to late November. She also noted that the binder from the 4th Annual New Landowner Conservation Services Workshop has been uploaded to the District website. Additionally, she referenced the VASWCD Envirothon Grant handout, explaining that it is intended to solidify the District's capacity as host of the 2026 Envirothon Competition, and requested that it be signed by Chairman Graves for approval. D. Cox moved to approve the request. M. Sands seconded the motion. (D. Cox, M. Sands, unanimous)

R. Jacobs reported that he presented District offerings at the Lake of the Woods Garden Club meeting and sold a few rain barrels while there. He also provided a brief update on potential VCAP budget restrictions and the monthly budgeting process currently utilized by VCAP.

D. Massie reported that, with the recently approved variance requests, the District has already allocated 20% of the FY26 cost-share allocation from DCR. He also noted that Clean Water Farm and Basin Award nominations have been submitted. Additionally, he reported that he and other Ag staff completed engineering training with Sara Bottenfield – DCR Ag Cost Share Program Manager, Amanda Pennington – DCR District Engineering Services Manager, and Raleigh Coleman – Assistant Engineering Specialist, during which clarity was provided on some of the language on some documents and several scenarios were explored. He attended the VSWCB Farm Tour on Monday, followed by the Audit Sub-Committee meeting on Tuesday. During the Farm Tour, participants visited two feeding barns and examined challenges in watering systems. James Martin – DCR Director, Division of Soil & Water Conservation, gave a presentation on the VACS Program history, funding, and achievements, and Amanda Pennington discussed EJAA, inviting Directors to ask questions. At the Audit Sub-Committee meeting, assessments and remediations were discussed, and Mr. Massie noted he was asked to address concerns regarding the District's "C" score on its most recent engineering assessment.

T. Talley reported that he completed four days of Engineering Training with DCR and that he will soon attend Conservation Planning Training.

C. Sheridan reported that she, Lily, Trevor, and Kendall have completed Resource Management Plan (RMP) Training and now have access to the RMP Tracking Module.

G. Wichelns reported that potential routes for the placement of new electrical transmission lines from Lynchburg to Northern Virginia by Dominion Energy will be announced in January, and that push-back is expected; current speculation indicates the routes will be in Orange and Culpeper counties. He noted that Ms. Ross has all quarterly reports underway and that they will be submitted by October 15. He reported attending a Zoom meeting with the VASWCD regarding Technical Assistance funding allocations. He then briefly reviewed the Budget Template, which is prepared every two years to inform

the General Assembly of the District's operational and agricultural funding needs. He added that the General Assembly will meet in January for 2–3 months, with decisions expected during that period. He informed the Board that as part of his retiring on December 1, 2025, he will be leaving behind a calendar covering eight months of items to monitor upon his retirement, emphasizing that federal funding is decreasing and attention to priorities is important.

9) AGENCY REPORTS

DCR – D. Cross submitted a written report.

VDOF – G. Robeson reported that the VDOF Warrenton Office is currently accepting acorns through October 15. He also noted that the Department is preparing for fire season.

10) PLAN FOR OCTOBER COMMITTEE MEETINGS
